II. Right to Bargain Collectively	
The right of workers to bargain collectively over their wages, benefits and working conditions is under attack. We strongly support the right of all workers	

both the

public and private sector to join together for a collective voice at work. Collective bargaining is a way to solve problems and make workplaces function better for workers, employers, customers and the general public. 1. [For those states where public employees do not have the right to organize] Will you support legislation to give public employees – including home-based workers, such as child care providers and home health aides, who are paid with public funds -- the right to organize and bargain collectively? 2. #### III. Electability

Please explain what motivated you to run for this office and give a brief description of your campaign plan (include other means of organizational support and financial plan).

## VI. Education and School Budget

Private school vouchers undermine public education by taking scarce funds away

In today's global economy, this must include a strong system of public higher education with access for the children of working families and decent pay for college and university employees.

1. What is your position on charter schools and on lifting the cap on the number of charter schools chartered by universities?

I am opposed to charter schools. I do not support uncapping the number of schools that a university can charter, nor the uncapping of the overall number of charter schools that exist. I will fight against all expansions of charter schools and will work to cap-and-close

existing schools, shifting students and dollars back to quality public schools with union teachers.

2. State laws regulating charter schools in Michigan are among the nation's weakest, allowing for a variety of different abuses of taxpayer money to benefit the for-profit companies running them. Will you support legislation to increase regulation of these existing charter schools to ensure they are held accountable for how their funds are used?

Yes - I support ensuring that all charter schools are answerable to their local school boards, the same as public schools.

#### IX. Equal Pay

The Equal Pay Act makes it unlawful to pay women less than men for work that is deemed substantially equal and/or identical, unless the pay difference is based on seniority, experience or other legitimate factors. Although equal pay has been the law for 35 years, women are still paid less than their male counterparts, despite having similar education, skills and experience. Often, this is because women are concentrated in certain occupations that have historically been paid less than those dominated by men. Insisting on pay equity, equal pay for work of comparable value, even if jobs are not identical, is one way to address persistent inequality.

1. Will you support measures that would end pay discrimination?

Yes and I'm proud to have worked to support such legislation as a staffer in both the State Senate and US House of Representatives.

2. Will you co-sponsor pay equity legislation?

Yes and I'm proud to have worked to support such legislation as a staffer in both the State Senate and US House of Representatives.

#### X. Privatization

In order to cut costs, state and local governments sometimes privatize by contracting out union jobs to low-paying, non-union employers. The UAW opposes any privatization measures that undermine accountability in public programs.

One of the worst examples of privatized services in the public sector is our correctional food systems. When these were handed over to private businesses, they increased prices, decreased quality, and served incarcerated citizens food that was riddle with maggots. I'm glad to see these services being returned to the public sector, with public employees, where they belong.

## XI. Minimum Wage

A fair minimum wage is fundamental to a social economic system that guarantees a decent minimum reward for work. A fair minimum wage not only reduces costs for safety net programs, but also acts as an economic stimulus in the communities in which low-wage workers live.

1. Will you support an increase in the state's minimum wage?

<u>Yes - I support eliminating the disparity between tipped and non-tipped wages and moving to a \$15/hour minimum wage, indexed to the CPI.</u>

2. Will you support a provision to index the state's minimum wage so that legislative action is not necessary to increase it to keep pace with inflation?

Yes, though the CPI is a better measure since inflation rates can be artificially depressed by decreases in, for example, energy prices.

#### XII. Unemployment Insurance

The deep recession and continuing high unemployment levels show the importance of a strong unemployment insurance system. Unfortunately, a

of states have responded to strains on system finances by enacting benefit cuts instead of insisting that employers replenish the funds.

Will you oppose cuts in support for the unemployed and instead support legislation to improve unemployment benefits and expand eligibility?
